## Introduction

These rules govern the way that we operate the SRA Compensation Fund. This is a discretionary fund of last resort for making grants to people whose money has been stolen, or has not been accounted for, as a result of the acts or omissions of those regulated by us, and to relieve losses for which firms authorised by us should have had, but did not have, insurance.

It is funded by contributions from individuals and firms authorised by us.

We have provided guidance on the way we operate the fund.

1. The [SRA \[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) shall establish and maintain a fund for making grants in respect of claims made in accordance with these rules.
2. ## **Rule 2: The object of the Fund**

The [Fund](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] is a discretionary fund of last resort and no [person](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person] has a right to a grant enforceable at law.
3. The primary objects of the [Fund](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund] are:
  1. to replace money which a [defaulting practitioner](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] or a [defaulting practitioner's](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner's) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner's] employee or [manager](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#manager) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#manager] has misappropriated or otherwise failed to account for; and

For any grant to be made out of the [Fund](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund), an [applicant](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) must satisfy the [SRA](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) that the [applicant](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) is eligible in accordance with rule 4 and (save in respect of a grant made under rule 3.4) has suffered or is likely to suffer:

3. For the purposes of rule 3.1(b):
  1. an individual whose dealings have been in a personal capacity with the [defaulting practitioner](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account shall be deemed to have suffered hardship; and
  2. a body corporate, or an individual whose dealings have been in a business capacity with the [defaulting practitioner](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#defaulting-practitioner] and who has suffered or is likely to suffer loss due to a failure to account must provide evidence to satisfy the [SRA](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] that it, he or she (the body or individual) has suffered or is likely to suffer hardship.
3. The [SRA](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may make a grant as an interim measure.
4. A [person](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person) is eligible under this rule to apply for a grant out of the [Fund](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Fund) where the [person](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person) :
  1. is an individual; or
  2. at the time the application is made, is a sole trader, [partnership](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#partnership) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#partnership\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#partnership), body corporate, unincorporated association or mutual association with an annual [turnover](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) [\[https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#turnover\]](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#turnover) of less than £2 million, and does not fall within rule 4.2, 4.3(a) or 4.4(a).
5. The [SRA](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] may deduct from any grant such amount as it sees fit so that the [applicant](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] will not be in a better position by reason of a grant than the [applicant](https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant) [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#applicant] would have been in if no loss had been sustained.
