

Scottish solicitor (full practising rights)

Updated 5 March 2025

Here are the steps you need to take before applying for admission as a solicitor of England and Wales. We also offer guidance on when to do this, but the steps do not have to be done in a set order.

You'll also find a personalised SQE qualification checklist within mySRA (in 'My profile') that tracks your progress to admission and highlights next steps.

Create a mySRA account and add your jurisdictions - do this first

- Create a mySRA account this is where you will tell us about your degree, apply for any SQE exemptions, and finally apply for admission. Find out how to <u>create an</u> account [https://higher-rights.sra.org.uk/mysra/get-mysra-account/#heading_a27d].
- Tell us you are a qualified lawyer in mySRA. You do this in the 'My profile' section under 'Jurisdiction'. Please click 'add jurisdiction', select your professional title, and add the date you qualified. This automatically tells us you do not need to have qualifying work experience and what SQE exemptions you may be entitled to.
- Create an SQE assessment account to book your SQE1 exam and get your results. <u>Find out how [https://sqe.sra.org.uk/registering-and-booking]</u>.
- Please make sure the names match exactly on the two accounts.

Validate your degree - anytime

- Your degree must be equivalent to a <u>UK level 6 qualification [https://higher-rights.sra.org.uk/become-solicitor/sqe/check-validate-qualification/degree-equivalent/]</u> and can be in any subject. This would be a qualification or apprenticeship at level 9 or above of the Scottish Credit and Qualifications Framework, <u>accredited by the Scottish Qualifications Authority (SQA) [http://www.sqa.org.uk/sqa/files_ccc/Guide_to_Scottish_Qualifications.pdf] or awarded by a Scottish degree awarding body. - You can also apply for equivalence to a degree using other qualifications and/or relevant work experience. Find out how to <u>apply for an equivalence [https://higherrights.sra.org.uk/become-solicitor/sqe/check-validate-qualification/]</u>.

Retrieve SQE assessment results and/or exemptions - passed all relevant exams

- You can apply for the agreed SQE2 exemptions for your legal qualification. Find out more about this <u>exemption [https://higher-rights.sra.org.uk/become-solicitor/qualified-lawyers/sqe-exemptions/agreed-exemptions-uk-lawyers/]</u>.
- You'll need to retrieve your SQE1 results in mySRA once you have passed all your required assessments. Log into mySRA, and in 'Start a new application' you'll find the 'Retrieve your SQE results' application.

Background checks and suitability - just before applying for admission

- We check your suitability when you are applying for admission. You can also speak to us early if you have <u>any potential concerns [https://higher-rights.sra.org.uk/becomesolicitor/character-and-suitability/]</u>.
- You will need to do a background check/screening.Once complete, you are ready to apply for admission. Find out how to <u>apply for screening [https://higher-rights.sra.org.uk/become-solicitor/admission/screening/]</u>.



Applying for admission

- When applying, you will choose 'Solicitors Qualifying Examination route' on the application. Find out more about <u>applying for admission [https://higher-rights.sra.org.uk/become-solicitor/admission/admission-forms-fees/].</u>
- You will be asked to upload a copy of a certificate of good standing from all jurisdictions where you hold a legal professional qualification and have been admitted.
- The certificate(s) must be less than three months old (we recommend that the date of issue is no longer than two months on the date you make your application) and confirm:
- your date of admission
- that you are in good standing
- that you have not been subject to any disciplinary proceedings
- that there are not any pending disciplinary proceedings against you
- that you are currently entitled to practise.

Applying for a practising certificate - after choosing your admission date

What you need to do to become a solicitor through the SQE route

OR

Degree or equivalent



Validate a UK degree or other level 6 qualification (level 9 or above in Scotland)





Apply for an equivalence using other qualifications or experience

SQE assessments



Create an SQE assessment candidate account at sqe.sra.org.uk



Pass SQE1 or apply for individual exemption. Then apply for the SQE2 agreed exemption
