The Government's financial sanctions regime is frequently changing. In recent weeks we have seen a number of changes to the regime as the Government adapts to the challenges it faces. You should keep up to date with these changes to make sure you are compliant.

We have collected data about how you have been dealing with the sanctions regime. There will now be a programme of on-site inspections and desk-based reviews to assess firms' sanctions risk exposure and how they are mitigating their risk.

The date for payment of the first Economic Crime Levy (ECL) is now drawing near. You should check whether this affects your firm based on your turnover in the period 1 April 2022 to 31 March 2023. HMRC have published guidance to help you understand if this applies to you.

If as part of its approach to sanctions compliance, your firm relies on the Legal Services General Licence in relation to Russia and Belarus, you should be aware that this expires on 28 October 2023. All reporting obligations under paragraph 10 within the licence must be completed by that date. HMRC is currently considering whether or not to renew the licence for the future.

If you hold frozen assets under the sanctions regime, you must submit a report to OFSI by Friday 10 November 2023. This must include the value of all such assets as of close of business on Friday 29 September 2023, so no reports should be submitted before this date. Your report must include details of all funds or economic resources frozen in the UK as well as those overseas, where these funds or economic resources are subject to UK financial sanctions legislation.
