The diversity profile of individuals in our enforcement processes

The report shows overrepresentation of men and solicitors from Black, Asian and minority ethnic backgrounds in concerns raised with us and reflects patterns we have seen for some time.

We have commissioned several external reviews to look at these issues, building on work that The Law Society undertook in 2006 before the SRA was established. We published our commitments following the most recent review by Professor Gus John, the Independent Comparative Case Review (ICCR), and have recently reviewed the work we have been doing to meet those commitments.
