Introduction

These rules make provision for all notices given by the SRA and applications made to it under the SRA's rules and regulatory arrangements. They also make provision for internal reviews and external appeals against our disciplinary and regulatory decisions.

This introduction does not form part of the SRA Application, Notice, Review and Appeal Rules.

Part 1: Applications and notices

Rule 1: Applications

- 1. An application made under the <u>SRA's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] regulatory arrangements [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements] must be made in writing, where appropriate, in the <u>prescribed [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> form correctly completed, and be accompanied by:</u>
 - 1. any <u>prescribed [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed]</u> fee or charge; and
 - 2. any information and documents which may be <u>prescribed</u> [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#prescribed], or reasonably requested by the <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.
- 2. If you make an application to the <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, you do not need to submit all payments, information, and documents simultaneously, but the application will only be made once the <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> has

- received all of the payments, information and documents relating to it.
- 3. You must ensure that all details provided in connection with any application you make to the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] are correct and complete. You must notify the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] as soon as you become aware of any changes to any information supplied.
- 4. As soon as reasonably practicable, the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall give notice to the applicant of the decision made in respect of their application, and shall give notice of the decision to any other person to whom the application relates. If the application is refused, the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] will provide reasons for the decision and will inform the applicant and any other person to whom the application relates, of any right they may have to apply for a review or appeal of the decision.
- 5. The <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> shall give notice to an applicant for authorisation under the SRA Authorisation of Firms Rules, of the decision in respect of their application before the end of the decision period, which is the period of 6 months beginning with the day on which the application is made.
- 6. The SRA [https://higher-rights.sra.org.uk/solicitors/standardsregulations/glossary/#SRA] may, on one occasion, give the applicant a notice (an "extension notice") extending the decision period in rule 1.5 by such period as may be specified in the notice but:
 - 1. an extension notice must only be given before the time when the decision period in rule 1.5 would end, but for the extension notice;
 - 2. the total decision period must not exceed 9 months; and
 - 3. the extension notice must set out the reasons for the extension.
- 7. If the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] has not notified the applicant of its decision within the decision period in rule 1.5 or as extended by rule 1.6, then for the purpose of any rights of review or appeal under Part 2 of these rules, the application is deemed to have been refused under rule 2.2 of the SRA Authorisation of Firms Rules and that decision to have been notified to the applicant on the last day of the decision period in rule 1.5 or as extended in rule 1.6. This does not prevent the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] subsequently granting or refusing the application.

Rule 2: Notices

- 2. Any notice under the SRA's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] regulatory arrangements [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements] must be given in writing by delivering it, or sending it by post or by electronic mail, to the recipient's last notified postal or electronic mail address, as appropriate.
- 3. If the intended recipient of a notice is represented, the notice may instead be given by sending or delivering it to the representative's practising or business address, or electronic mail address.
- 4. The giving of notice will be deemed to have been effected:
 - 1. if sent by electronic mail or delivered or left at an address before 4.30pm on a working day, on that day, or in any other case on the next working day after the day on which it was sent, delivered or left;
 - 2. if sent by ordinary post:
 - 1. in the case of first class post, on the second working day after the day on which it was posted, and
 - 2. in the case of second class post, on the fourth working day after the day on which it was posted.

Part 2: Reviews and appeals of decisions

Rule 3: Power to conduct a review

- 3. The <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may:
 - 1. where an administrative error in, or in relation to any decision comes to the SRA's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] attention, correct the error without the need to undergo a review under this Part;
 - 2. review all or part of any regulatory decision reached by it, of its own initiative, under this Part.
- 4. Subject to rule 3.3, the <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> may review all or part of any of the regulatory decisions set out in annex 1 on the application of the <u>person [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> who is the subject of the decision.
- 5. An application cannot be made for a review of:
 - 1. a decision reached following a review or appeal;
 - 2. a decision which has been made by agreement under rule 8.2 of the SRA Regulatory and Disciplinary Procedure Rules.
- 6. Subject to rule 3.7, the <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] shall not, save</u>

- in exceptional circumstances, review a decision more than one year after it was made.
- 7. An application for a review of a decision must be made within 28 days of:
 - 1. notice being given of the decision, or reasons for the decision (if later);
 - 2. any deemed refusal under rule 1.7; or
 - 3. or regulation 19 of the European Communities (Lawyer's Practice) Regulations 2000 to the extent that they continue to have effect in accordance with regulation 6(r) of The Services of Lawyers and Lawyer's Practice (Revocation etc.) (EU Exit) Regulations 2020

and must explain the grounds of review and provide reasons and any evidence in support.

- 8. Subject to rule 3.7, if the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]_decides to review a decision on its own initiative, it must give any person [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#person] who is the subject of the decision, notice of its decision to conduct a review and an opportunity to provide written representations on the appropriate outcome under rule 4.2.
- 9. Rules 3.4 and 3.6 do not apply where the SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] decides to review a decision made under rule 3.1(g) of the SRA Regulatory and Disciplinary Procedure Rules to make an application to the Tribunal [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Tribunal].

Rule 4: Decisions on review

- 4. A review will usually be determined by an <u>authorised decision</u> <u>maker [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-decision-maker]</u> on consideration of written evidence alone. An <u>adjudicator [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudicator]</u> may at their sole discretion invite the relevant person to be interviewed by an authorised decision maker accompanied by their representative (if any).
- 5. Subject to rule 4.3, on a review (save for a review of a decision made under rule 3.1(h) of the SRA Regulatory and Disciplinary Procedure Rules), the <u>authorised decision maker [https://higherrights.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-decisionmaker]</u>, as appropriate may, where they consider the original decision was materially flawed or there is new information which would have had a material influence on the decision:
 - 1. uphold the original decision;

- 2. overturn the decision in whole or in part;
- 3. make any other decision which could have been made by the original decision maker; or
- 4. remit the decision for further investigation or consideration.
- 6. On a review of a decision made under rule 3.1(g) of the SRA Regulatory and Disciplinary Procedure Rules to make an application to the https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Tribunal, the authorised decision maker may also overturn the decision where they consider that the conditions in rule 6.1 of the SRA Regulatory and Disciplinary Procedure Rules are no longer met.
- 7. On a review of a decision made under rule 3.1(h) of the SRA Regulatory and Disciplinary Procedure Rules, the authorised decision maker, as appropriate may exercise any of the powers set out at rule 4.2, where they consider that:
 - 1. the person had complied with the requirements made under rule 11.1(b) of those rules; or
 - 2. the person had taken all reasonable steps to ensure they receive SRA [SRA [communications but did not receive the notification under rule 11.1 of those rules.
- 8. A review of a decision made by an <u>adjudicator [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudicator]</u> may only be carried out by another <u>adjudicator [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudicator]</u> or an <u>adjudication panel [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudication-panel]</u>. A review of a decision made by an <u>adjudication panel [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudication-panel]</u> may only be carried out by another <u>adjudication panel [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#adjudication-panel]</u>.
- 9. A review will not be conducted by the authorised decision maker who made the decision under review. For avoidance of doubt this does not apply in respect of corrections under rule 3.1(a).

Rule 5: Appeals to the High Court or Tribunal

5. Unless otherwise provided in the relevant statute, or rules of the <u>Tribunal [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Tribunal]</u>, <u>COURT [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#court]</u> or of the Legal Services Board, any appeal to the High Court or <u>Tribunal [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Tribunal]</u> against a decision set out in annex 2 or 3, as appropriate, must be commenced within the period of 28 days from the date of notification of the decision that is subject to appeal.

Rule 6: Taking effect of decisions subject to review or appeal

- 6. Unless specified otherwise, subject to rule 6.2, a decision takes effect:
 - 1. if no application for a review or appeal is made, on the expiry of the date for bringing such an application under these rules; and
 - 2. if an application for a review or an appeal is made, on the date any review or appeal has been determined or discontinued.
- 7. The <u>SRA [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#SRA1</u> may direct a decision to take immediate effect, where it considers that it is necessary in the public interest to do so.

- A decision made under regulation 3.1(a) not to be satisfied that an individual holds a legal professional qualification that is recognised by the SRA, which confers rights to practise in England and Wales or in an <u>overseas [https://higher-rights.sra.org.uk/solicitors/standardsregulations/glossary/#overseas]</u> jurisdiction.
- 3. A decision made under regulation 3.1(b) not to be satisfied that an individual holds a <u>degree [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#degree]</u> or qualifications or experience which are equivalent to a <u>degree [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#degree]</u>.
- A decision made under regulation 3.2 to refuse to grant an individual an exemption from all or part of the assessment under

- regulation 1.1(a).
- 5. A decision made under regulation 3A.2 not to be satisfied that an individual has completed all or any part of the <u>academic stage of training [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#academic-stage-of-training] or the <u>vocational stage of training [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#vocational-stage-of-training]</u> by equivalent means.</u>
- 6. A decision made under regulation 3B.2(a) to refuse to recognise all or any part of an apprenticeship.
- 7. A decision under regulation 3B.2(b) to require further steps or training to be undertaken including imposing conditions.
- 8. A decision made under regulation 3E.2(a) to refuse to recognise all or part of a <u>period of recognised training [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#period-of-recognised-training]</u>.
- 9. A decision made under regulation 3E.2(b) to require further steps or training to be undertaken including imposing conditions.
- 10. A decision made under regulation 5.1 to refuse to issue a certificate of satisfaction.
- 11. A decision made under regulation 5.2 not be satisfied as to an individual's <u>character and suitability [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#character-and-suitability]</u> to be a <u>solicitor [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u>.
- 12. A decision made under regulation 5.3 to refuse to admit an individual as a <u>solicitor [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> after a certificate of satisfaction has been issued.
- 13. A decision made under regulation 5.6(a)(ii) to remove a <u>solicitor's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> name from the roll.
- 14. A decision made under regulation 5.6(b) to refuse to remove a <u>solicitor's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> name from the roll.
- 15. A decision made under regulation 5.9 to refuse to restore a <u>solicitor's [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#solicitor]</u> name to the roll.
- 16. A decision made under regulation 7.1(b) to impose conditions on a practising certificate or the registration of a European <u>lawyer</u> [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#lawyer], foreign lawyer [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#foreign-lawyer] or <u>Swiss lawyer [https://higher-rights.sra.org.uk/solicitors/standards-regulations/glossary/#Swiss-lawyer]</u>.
- 19. A decision to refuse approval for the taking of steps specified in conditions under regulation 7.1(b).
- 20.
