The deadline for completing the accountants' reports spot-check has now passed. If your firm was selected to take part, you need to submit the information as soon as possible to avoid the possibility of regulatory action. We will be contacting firms who have not met the deadline, so please get in touch if you have had issues submitting your data.

We have written to a randomly selected cross section of 750 firms, requiring your Compliance Officer to provide information on how you identify and handle first tier complaints. If you have been asked to participate, you have until 28 February to reply. It is a regulatory obligation that you respond.

We have issued a warning notice about marketing your services to the public. We are particularly concerned about the behaviours of some firms doing high-volume consumer claims work. Unsolicited approaches such as cold calling and door knocking are prohibited, while firms need to make sure that information on 'no win, no fee' arrangements is clear and accurate, including information on charges and the risks around costs.

The Office of Trade Sanctions Implementation (OTSI), launched in October 2024, has the power to investigate suspected breaches of specific trade sanctions and take enforcement action. OTSI has recently issued new guidance, which has implications for the legal sector.

On 8 January 2025, HM Treasury placed sanctions on a domestic far-right group, Blood & Honour, freezing their assets under the Counter-Terrorism (Sanctions) (EU Exit) Regulations 2019. This is the first time that these measures have been applied to a far-right group.
