

# Qualifying through the Equivalent Means pathway

September 2024

You can only qualify through this route if you meet our <u>transitional</u> <u>requirements</u>. Here are the steps you need to take before applying for admission as a solicitor of England and Wales.

### **Complete the Professional Skills Course**

- We check your suitability when you are applying for admission. You
  can also speak to us early if you have <u>any potential concerns</u>
